DESCRIPTION:

The Research Institute of Horticulture is looking for a candidate for the position of adjunct in the Weed Science Laboratory. The Candidate's duties will include: (1) planning, setting up and conducting field and greenhouse experiments in the field of weed management in vegetable crops, (2) interpretation of research data obtained from experiments and elaboration of research reports from the studies, (3) handling a computer programs necessary to conduct research, including ARM, Statistica and Corel, (4) writing publications for scientific journals in Polish and English and popular articles, as well as active participation in national and international conferences, (5) obtaining research projects, (6) conducting a lectures and workshops on integrated weed management.

The candidate shall hold the academic degree of doctor, in accordance with Article 114 of the Act of 27 July 2005 *The Law on Higher Education* (Journal of Laws No. 164, item 1365 with amendments) in the field of agricultural sciences, horticulture, interdisciplinary knowledge on methods of weed management, as well as the action and use of herbicides and adjuvants in vegetable crops and current research directions in this field. Moreover, he should have qualifications and skills allowing him to conduct research on various methods of weed control in vegetable crops and to achieve the research aims in the Weed Science Laboratory.

It requires at least 2 years of professional experience in a scientific unit, at a research position, in conducting field and greenhouse experiments, knowledge of the principles of weed management in vegetable crops and the use of biostimulators and growth regulators, knowledge of EPPO standards, according to which the experiments on the use of herbicides, adjuvants and growth regulators are conducted, scientific achievements in horticulture supported by original publications, knowledge of methods of weeds control in vegetable crops, fluent use of a computer and ARM program and good knowledge of English, allowing for writing scientific papers.

Candidates are asked to submit the following documents:

- application for employment as an adjunct,
- a copy of diploma confirming the possession of a doctoral degree,
- a scientific biography with a list of publications,
- other documents confirming the candidate's qualifications, including current certificate on the use of plant protection products,

- declaration of no criminal record,
- declaration of knowledge of English, confirmed by a certificate,
- a statement that in the event of being accepted for work, the Research Institute of Horticulture will be the first place of employment of the candidate.
